## International workshop on the potential of peaceful conflict resolution approaches in tackling radicalisation

on 14 May 2013 at the National Institute of Criminology,

(Budapest, Hungary, 1122 Budapest, Maros utca 6/a.)

The conference is organised by the Foresee Research Group in partnership with the National Institute of Criminology (OKRI), within the framework of the REDICT Project (Resolving Disputes in twenty-first Century - 2011-2013, Consortium leader: European Institute for Reconciliation, Mediation and Arbitration, Czech Republic), supported by the European Commission's Grundtvig Programme

(Adult Learning Programme within the Lifelong Learning Programme of the Education)

What is the potential of peaceful conflict resolution in preventing and handling the issue of radicalisation? In what specific ways, at what stages and to what extent can we apply the restorative justice approach and its practices (such as mediation, conferencing and peacemaking circles) in supporting communities affected by intercultural clashes?

This workshop intends to make a link between professionals dealing with peaceful conflict resolution techniques, on the one hand, and with the issue of radicalisation and hate crimes, on the other. During this interactive day our attempt is to think loudly and collectively on the above-raised questions: mapping the possible connection points, shared dilemmas, ideas, lessons learnt during our activities and future directions concerning the fields of radicalisation-prevention and conflict resolution – with the possibility of being self-critical and highlighting both successes and challenges.

The workshop will provide an interactive forum for professionals from various relevant fields (lawyers, judges, prosecutors, police, probation workers, social workers, mediators, policy makers, community workers etc.) to share their experiences and thoughts in the fields of radicalisation and conflict management and to enable them to create partnerships for future joint initiatives.
