- engage in a process of a detailed consideration and agreement on **justice outcome** --) **WHAT?**

Work Package Five

WP5 – Foresee - Objectives

- Identifying **the conditions and circumstances** required for the successful application of the restorative justice approach and practices in conflicts in intercultural settings (in local communities).
- Identifying those **conflict areas** in which restorative practices can be effectively applied in intercultural settings, and to evaluate the possible outcome of the restorative interventions.
- Finding out how and at what points restorative theory and practice can be **integrated into the existing institutional structure** with special focus on the justice, law-enforcement and welfare system, in order to make the operation of the existing statutory system more effective.
- We also aim to assess how the restorative practices and approach can be **aligned with other professions/intervention methods** (community development, child protection, social work services etc.), and to identify the limitations of the different intervention methods.

OUR INTERCULTURAL CONTEXT



- An 'ISLAND OF PEACE' or a 'VOLCANO'
- SEVERAL intersecting CULTURES (ethnic, religion, life-style, world-view) i.e. COMMUNITIES
- Existing patterns and patterns of conflict transformation
- Why is it difficult to talk and discuss about injuries and pain in direct, personal communication VS. communication through representatives of groups/cultures or by MEDIA

TWO YEARS OF WORK

- **PREPARATION** (Concept paper on Securitization, and working material 'Naming the Gypsy' by Balázs Berkovits and Eszter Balogh)
- **CHOOSE THE SITE**, make **CONTRACT**
- **FIND LOCAL COORINATOR, BUILD SUPPORT GROUP**
- **BUILD TRUST**, **COOPERATE**, **VIDEO-DIARY**
- **DIAGNOSIS**: research, mapping and reflection
- **TEST CASES** : Observe direct practice of conflict transformation. Evaluation with **LOCAL RESEARCHERS**.
- **RJ INTERVENTIONS** (services, training, implementation)
